November Bond Will Affect All Students, All Schools

The Warren Woods Public Schools Board of Education has voted unanimously to place a comprehensive, \$20 million bond proposal on the November 7 ballot which it anticipates will affect students, parents, and the entire Warren Woods community.

If approved by voters, the \$20.33 million bond proposal was designed to enhance student safety and school security, to remodel schools and upgrade the learning environment, and to help assure that our instructional technology is current.

It will further our district mission if our school district is up-to-date, and that our students learn in facilities that support a 21st Century education.

Over 100 projects are included in the bond proposal. They range from secure entrances to upgrading HVAC systems to remodeling instructional areas to roof replacements to asbestos abatement. The list of projects is a long one. (*See Bond projects planned at each school below and continued on page 4.*)

If the bond proposal is approved, a person owning a \$100,000 home will pay approximately 30¢ more per day in property taxes. (Most people living in the Warren Woods Public School District will pay less than 30¢ per day!)

Residents can vote at the polls on November 7 or any time after September 23 by absentee ballot.

School Bus Stop Schedule

The Warren Woods Transportation Department has automated our school bus stop schedule system. To determine your child's stop go to the Warren Woods Public Schools website at <http://www.warrenwoods.misd.net/>

1. click [OUR DISTRICT]
2. click [DEPARTMENTS]
3. click [TRANSPORTATION]
4. click on the school bus icon shown above.

You will be redirected to WebQuery which is linked to our bus routing program. Once there, select your child's school from the dropdown menu, select their grade and enter your address number and street.

Only students who live further than 1.5 miles from the school or in pre-determined hazard areas are eligible for transportation.

Schools of Choice students are not eligible. If your child is eligible, the approximate stop time, stop location and bus number will be displayed for both morning and afternoon transportation.

Please note that many of the stop locations change each year to maximize student safety, so check WebQuery prior to the start of the school year.

SMTEC Launches Early Middle College Medical Assistant Program In 2017-18

SMTEC enrolled eighteen 11th grade students in its Early Middle College Medical Assisting Program beginning with the 2017-18 school year. Over the course of the next three years, these students will earn both high school and college credit, complete externships with local business/medical partners, prepare and take the American Association of Medical Assisting national exam, and earn an Associates degree in Health Science Technology from Baker College-Clinton Township Campus.



SMTEC has been offering a high school course in Medical Assisting for many years; however, this program did not culminate with the industry credential. "We now have the opportunity for our students to leave high school directly prepared for the workforce in a high-wage, high-demand, high-skill area to help fill the 'gap' of talented workers right here in Macomb County," said Dr. Szuminski, Director of Career and Technical Education for SMTEC.


SMTEC programs have a long-standing partnership with Baker College-Clinton Township, where students have often participated in college-based activities, attended tours and open houses, and many times enrolled in one of their career programs after high school. "Baker is excited to provide this outstanding option for students who want to earn a certificate or Associates degree through Baker College," states Dr. Peni Aldrich, Director of Baker College's Running Start Program. "Recent Michigan legislation allows high schools students to remain in high school for a '13th' semester or year while they are earning an industry certificate or Associate's degree and provides additional funding to schools to help make this possible. Essentially, the Early College Medical Assistant students will incur very minimal, if any, costs associated with this program."

Junior students will enroll in Medical Assisting 1 and Anatomy & Physiology at Warren Woods Tower High School, earning both high school and college credit. In addition, they will spend time on the college campus joining college and professional activities, utilizing library and support services, as well as completing lab or other classroom assignments at the college. This model helps the students transition from being high school students to college students. Marie Van Huysse, EMC instructor at Warren Woods Tower High School, states that "we are very impressed with the group of students who have enrolled in this first cohort. They show great dedication to the courses and are eager to become a part of the health care team." As seniors, students will enroll in Medical Assisting 2 at Warren Woods Tower School and then complete all additional courses at the Baker College-Clinton Township Campus. In Year 13, students will prepare for the AAMA exam, complete externship hours, as well as take the national exam. Students choosing to enter the workforce upon earning the AAMA credential may do so; others, may opt to remain for an additional semester to complete the requirements for the Associates degree in Health Science Technology.

SMTEC has been offering high quality career and technical education courses to students enrolled in Center Line, Fitzgerald, Van Dyke, and Warren Woods Public School districts since 1980. Their mission is to prepare all high school students for both career and college transitions upon graduation.

PARENTS VACCINES REQUIRED FOR SCHOOL ENTRY IN MICHIGAN

Whenever children are brought into group settings, there is a chance for diseases to spread. Children must follow state vaccine laws in order to attend school. These laws are the minimum standard to help prevent disease outbreaks in school settings. The best way to protect your child from other serious diseases is to follow the recommended vaccination schedule at www.cdc.gov/vaccines. Talk to your health care provider to make sure your child is fully protected.

During disease outbreaks, incompletely vaccinated students may be excluded from school. Parents and guardians choosing to decline vaccines must obtain a certified non-medical waiver from a local health department. Read more about waivers at www.michigan.gov/immunize.

*If the child has not received these vaccines, documented immunity is required. All doses of vaccines must be valid (correct spacing and ages) for school entry purposes.

Student Directory Information

Each year the district provides public notice to students and their parents of its intent to make available, upon request, certain information known as "directory information". The Board designated, as student directory information, a student's name, address, phone number, photograph, date and place of birth, major field of study, participation in officially recognized activities and sports, height and weight, if a member of an athletic team, dates of attendance, date of graduation, awards received, or any other information which would not generally be considered harmful or an invasion of privacy, if disclosed.

Parents and adult students may refuse to allow the district to disclose any or all of such directory information upon written notification to the district within ten (10) days after receipt of the district's public notice. A form for this purpose is available at each building or at the pupil accounting office.

The district may disclose directory information on former students without student or parental consent. The superintendent shall prepare procedures to ensure that students and parents are adequately informed each year regarding their rights to inspect and review the student's education records.

The principal of each building or the department is charged with the responsibility of maintaining and safeguarding the educational records. Employees of WWPS in the areas of instruction, special services, administration, research / evaluation and student records are authorized to have access to records in the educational interest of the student.

This would include the student's academic, physical, emotional, personal, social and vocational decisions. Any other person except those agencies specified in the Act must have a signed consent of the parent or eligible student to gain access to the educational records and request amendments prior to their being released.

Special Education and Section 504 Child Find Notice

The Warren Woods Public Schools Department of Special Services has the duty to locate, evaluate, and identify any child residing in the District who qualifies for special Education services or Section 504 accommodations or services.

With the passage of the individuals with Disabilities Education Amendments/Revisions of 2007 (IDEA), the Senate and Federal Government continue to assure that all handicapped children (ages 0-25) may receive special education services. The term "children with disabilities" refers to children: With cognitive impairment, hearing impairments (including deafness)

speech or language impairments, visual impairments (including blindness), emotional impairments, physical impairments, autism, traumatic brain injury, other health impairments, or specific learning disabilities, or any combination of these impairments; and who, by reason are in need of special education and/or related services.

In compliance with the IDEA Act, Public Act Amendments/Revisions of 2007, Public Act 451 of 1976 and P.L.94-142 (Education for All Handicapped children) the Macomb Intermediate School District (M.I.S.D.) and all twenty-one (21) school districts have developed a plan, which outlines

services for all eligible handicapped children and youth.

The M.I.S.D. plan describes the special education device delivery throughout Macomb County. Children eligible for Section 504 accommodations or services include those children who have a physical or mental impairment that substantially limits a major life activity.

Pesticide Control Act

Warren Woods Public Schools has adopted an Integrated Pest Management program (IPM). The community is advised that pest control services are routinely provided once each month in the district's buildings by a certified applicator. Special applications take place as needed. **Elite Pest Management** employs an integrated pest management program using pest control methods which impose the least possible hazard to people, property, and the environment. This IPM program does not rely on routine pesticide applications to resolve problems. We use various techniques such as habitat alteration, sanitation, mechanical means, exclusion, etc. to prevent pests from becoming a problem. Adult & Community Education

Warren Woods Adult & Community Education proudly provides opportunities for many individuals in the community who wish to earn a high school diploma, prepare for a High School Equivalency (HSE) exam, improve math and English literacy, improve English skills, or participate in an enrichment class.

The High School Completion program, accredited by NCA-CASI, offers day and evening classes for adult learners who wish to earn a high school diploma and achieve high school graduation. Students may also prepare for a High School Equivalency test such as a GED, HiSET or TASC. Students must be 18 years of age on September 1st to enroll, but we believe you are never too old to earn your high school diploma. Students must also be Macomb County residents.

Students from local high schools may take advantage of the Credit Recovery program offered Monday through Thursday evenings to make up previously unearned credits.

English As a Second Language (ESL) provides year-round instruction to members of the community for whom English is not a primary language. Students improve reading, writing, listening, and speaking skills while also learning about citizenship, computers, job-seeking, and many other everyday skills.

Adult Basic Education (ABE) provides valuable literacy improvement to community members who qualify. While foundational classes help our adult students aged 20 and older gain the skills necessary to earn a high school diploma, other adults in the community who have already earned a diploma but lack basic skills may be

eligible for this program. ABE classes are also ideal for those seeking to prepare for the HSE tests and prep classes.

Senior citizens enjoy their weekly Game Day every Tuesday from noon until 3 PM. Local seniors gather to play pinochle, euchre, and other card and board games. Refreshments are provided, and there is no cost to participate.

Open to the rest of the community are enrichment classes such as Segment I and II driver training, yoga, cheerleading, line dancing. A full listing can be found on the Warren Woods Adult & Community Education website.

Official Discipline Policy

The following legal notice is required to be published by the state and or federal government. The following summary is taken from the official policy of the Board of Education. The full text of the discipline policy is available upon request.

Student Discipline – Generally

It is the Board's policy to provide students and staff with a safe learning environment free from substantial disruption. Consistent with this policy, the District may discipline students who engage in misconduct. Discipline may, but need not, include suspension or expulsion from school.

It is the Board's policy that students should rarely be suspended or expelled from school and that steps should be taken to minimize occurrences of suspension and expulsion. It is further the Board's policy to comply with all applicable state and federal laws related to student discipline.

It is the Board's expectation that this Board Policy, especially those provisions that require consideration of specific factors and the possibility of restorative practices before suspending or expelling a student, will reduce the number of out-of-school suspensions that exceed 10 days and the number of expulsions.

This Board Policy applies to all student conduct that occurs: (1) on school property; (2) at a school-sponsored or school-related event; (3) on the school bus; (4) traveling to or from school, including at a school bus stop; and (5) at any other time or place if the conduct has a direct nexus to the school environment.

Student Code of Conduct

The Board directs the Superintendent to develop and regularly update a student code of conduct. The student code of conduct must: (1) identify offenses that may result in discipline; (2) identify the possible disciplinary consequences for each offense, which may, but need not, include suspension or expulsion; (3) be consistent with Board policy and applicable state and federal laws, including laws requiring mandatory suspension or expulsion; and (4) include a copy of the section of this Board Policy entitled "Suspension from Class, Subject, or Activity by Teacher."

Definitions for purposes of this Board Policy:

- "Suspend" or "Suspension" means a disciplinary removal from school for less than 60 school days.
- "Expel" or "Expulsion" means a disciplinary removal from school for 60 or more school days.
- "Restorative practices" means practices that emphasize repairing the harm to the victim and the school community caused by a student's misconduct.

Education Records

The education records of any student enrolled in the Warren Woods Public Schools (WWPS) are protected under the Family Educational Rights and Privacy Act of 1974.

A parent or eligible student (one who has attained the age of 18 or is in a post secondary educational institution) may, and is encouraged to review their records. The review may be done by contacting the building principal and arranging an appointment. A member of the staff will accompany the reviewer to provide explanation and interpretation as required. If the parent or eligible student feels some portion of the record is inaccurate, misleading or otherwise in violation of privacy or other rights of the student, he or she may ask that the record be amended. If satisfaction is not achieved at the building or department level, a hearing will be held on the matter upon request. Following the decision of the hearing officer, if satisfaction is still not achieved, a written explanation may be added to the record of the rationale for challenging that record. Copies of educational records will be provided to parents or eligible students upon request. A charge may be made to cover duplication costs.

No records, files or dates directly relating to an individual student shall be made available to anyone without the consent and notification of the student or the parents or guardian of a student under the age of 18, except:

1. The teachers and officials of this school district who have a legitimate educational interest in such information, or unless
2. There has been a federal request for submission of student records in connection with the student's application for financial aid. The student or parent will be notified if officials of a school to which a student intends to enroll desire access to student records, or if a court has ordered access to such records, parental or student consent is needed.
