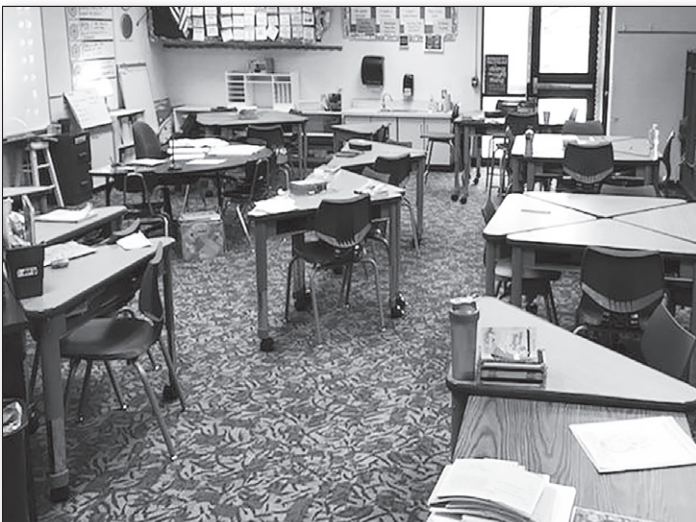

Warren Woods Reading Recovery Model

This year, we are excited to continue the expansion of the Reading Recovery within the district. Over the years, many of our administrators reported that our Reading Recovery-trained teachers provide whole school benefits because they're able to share expertise with colleagues. It was with this feedback, along with research, that prompted us to think bigger about our use of Reading Recovery within the district. The underlying premise of our elementary literacy model is to invest in our most valued instructional resource, our teachers.



The approach of our program is to develop ways to enhance our professional learning, which, we believe, will improve academic success for all our students. Investing in district literacy coaches, a Reading Recovery training site, and our work with Dr. Taylor, an area literacy consultant, allows us to expand our capacity to provide high quality and job embedded professional development to our elementary teachers. Our model empowers us to be able to learn, in greater depth, more about instruction and content so that our teachers and administrators can utilize research-based instructional practices.

Our implementation of Reading Recovery requires continued coordination and collaboration between our elementary schools, Oakland University, and our Warren Woods Macomb Area Reading Recovery training site. Next year, we are training four additional elementary teachers in Reading Recovery: Literacy Support. These teachers add to our current team of 11 elementary literacy staff. We were excited to end the year by celebrating the growth of many of our Reading Recovery students and their dedicated staff. Thank you for all of your hard work and dedication to learning and growing.

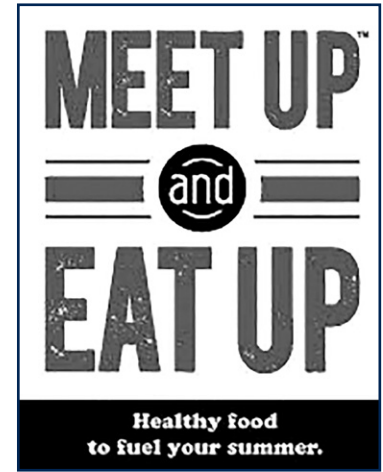
